Subject: Relieving of Teachers for Evaluations

Dear Principal,

You are aware that CBSE has initiated many steps to ensure smooth and fair conduct of Examinations. The next step is to ensure that evaluation is done with zero error. Though the policy of evaluation has been further strengthened this time, however zero error evaluation can only be ensured with the devotion, sincerity and availability of evaluators during evaluation process.

Accordingly, all the schools are directed to relieve their teachers immediately as per the instructions received from Regional Office concerned. Teachers should be relieved for full time, for all the days of evaluation of their subject. Teachers should be relieved by issuing the relieving certificate (Annexure-I). Same way, as soon as evaluation is over, Chief Nodal Supervisor (CNS) will also issue relieving certificate to the teachers (Annexure-II).

It may be noted that as per Chapter 12 of Affiliation Byelaws 2018, the Board can impose penalties and take strong action against schools "for not nominating and relieving teachers/Principals/staff for the evaluation of answer scripts of the Boards' examinations and other ancillary activities as per requirements of the Board" (please see para 12.2.10).

Above directions are therefore to be strictly complied with.
